Note: Following candidate are eligible to attend the counseling. 6. Gap year affidavit (if applicable)
7. Character Certificate in original
8. Migration Certificate in original.
9. Certificate of NCC/NSS/Sports/Cultural Activities/ others for verification of weightage (weightage will be given as per University norms).
10. Bring all your testimonials/ certificates/ documents **in original**, two set of attested photocopy
11. Demand Draft of Rs. 10,000/- (Rupees Ten Thousand Only) in favor of **Finance Officer, H.N.B. Garhwal University Srinagar (Garhwal)** payable at **Srinagar (Garhwal)**. The counseling shall be based on your final merit. If offered admission, the candidate has to take admission by July 31, 2017 by filling up a prescribed Admission Form and by depositing tuition and other fee, failing which admission offer to him/her will be treated cancelled and the seat will be offered to the next candidate in the merit list. The course fee of the B. PHARM. I SEM and B. PHARM. II YEAR (III sem. Lateral Entry) course is Rs. 32000/- (Rs. Thirty five thousand only) per year, the campus/college fee is Rs. 4000/- (Rs. Four thousand only) approx. per year including examination fee and Rs. 5000/- (Rs. Five thousand only) as a one time caution money (refundable).

The candidate may note that this letter is only for counseling and it does not give any guarantee for admission. The admission will be subject to the availability of the seats in the respective categories and fulfillment of the eligibility criteria. Those who have not passed the qualifying examination on the counseling date are not eligible for admission.

12. Category Certificate for SC/ST/OBC\*/ Defense person or dependent/PH/FF issued by competent authority.

**\*OBC certificate must be issued recently and the caste should be present in Central Government list. OBC Candidate should also submit recently issued original Non creamy layer certificate before the Counseling Board, by competent authority.**
