- 5) For Conducting Physical Fitness Test for B.P.Ed course, window for conducting it may be increased from 2 days to several days according to the applications of the candidates for the course.
- 6) In case, situation will not become conducive, and written examination will not be conducted, then admissions may be given on the basis of merit as per the guidelines of NCTE or by the approval of the competent authority of the University.
- 7) Looking to the present condition of the disease, the members were of the opinion to conduct the admission in the above courses on the basis of merit.
