- (II) Monthly progress report regarding the attendance and academic work done by the researcher Mr. Virendra Kumar undersigned by the supervisor and forwarded by the head of the department [in addition to annual report] will be submitted to the academic section every month for assessing and reviewing the work done by the research scholar and his attendance.
- (III) The Department/ supervisor/ head of the department will not provide any attendance statement and will not sign the fellowship bill for the period of his absence from the department i.e 07.06.2018 to till the date he comes back with administration letter citing its decision for the admission with conditions cited by the BOS committee.
