**Office Order 424/2022**

The University administration in its endeavour to maintain an all-India character and high standards of teaching, research and to ensure transparency in admission of students, recruitment of faculty and also to accomplish the goals of e-governance through Digitisation, had vide notification/letter nos. HNBGU/मान्यता/2021/225 dated 17-09-2021, HNBGU/मान्यता/2021/408 dated 31-12-2021 and HNBGU/मान्यता/2021/418 dated 06-01-2022 directed to the management committees of all concerned Colleges/Institutes which are affiliated with this University shall, henceforth, apply for extension of affiliation through on-line mode by getting themselves registered on the University Affiliation Module (Link-<http://ums.hnbgu.ac.in#login>).

As per U.G.C. (Affiliation of Colleges by Universities) Regulations, 2009, the continuation of Temporary Affiliation shall be granted by the University "on a year-to-year basis through inspection process prescribed in the Regulations." The application for such extension of approval is to be made on the prescribed form and upon payment of requisite fees.

It has been brought to the notice of the University Administration that certain affiliated colleges have not yet applied for such extension on an online mode and have not got themselves registered on the University Affiliation Module (Link-<http://ums.hnbgu.ac.in#login>) by the last date (i.e. 10 January 2022) of registration instead of providing ample opportunities of registration to the colleges/institutes.

In larger interest of the students, management committees of such affiliated colleges are directed to get their colleges/institutions registered on the, within 05 days (upto 19-01-2022, 5:00 PM) from this notification, failing which it shall be presumed that the management committees of such colleges are no longer interested in getting extension of temporary affiliation from the University.

The non-registration of colleges on the University Affiliation Module (Link-<http://ums.hnbgu.ac.in#login>) or uploading of incorrect / incomplete information on the University Affiliation Module shall be construed as a serious breach of conditions of affiliation.
