# Agenda Item No. 17.4:

To consider the proposal of the Construction Division about Settlement of the land dispute.

The following agenda has been provided by Construction Division (Annexure-7):-

Before the conversion of the University into Central University in Jan 2009, a number of court cases which included land disputes were pending. One such land dispute in Chauras campus at Vill- Sankron, Patti- Chauras, Kirtinagar, Tehri Garhwal arose in 2004, with one Sri Rajaram Bahuguna and Sri Ghannanand Bahuguna. After long litigation of the court case, the court passed the final order on the basic of the compromise filed by both the parties dated 03.12.2015. It was observed after some time that Sri Ghannand Bahuguna erected a structure on the excess land towards University measuring (0.90 X 21.00) or 18.90 Sq. Mtr. of land.

The University have two options: <u>First</u>, To file an eviction suit before the competent court. However, this is too time-consuming, expensive, and excusing, as noticed in other civil cases that the court takes too much time and the opposite party takes advantage of the delay whereas the University cannot do any development work during the pendency of the case. <u>Second</u>, Ask the party to compensate the University by providing an equal land area of equal importance or pay compensation of land measuring the above area, on current market rate. [Letter annexed].

The party gave his consent to pay competition of the land [Letter annexed]. As per market rate of Rs. 20 lakhs per nali (2000 Sq. Mtr), an amount of Rs. 1,89,000.00 (Rupees one lac eighty-nine thousand) will be paid by the party.

# Resolution:

Executive Council discussed the matter in detail and noticed that the practice adopted by Sri Ghannand Bahuguna is not at all acceptable. EC noted that if the university permits him to give money for the occupied land even as per the current market rate, then also this may allow other people to erect such type of structure in university land in future and later on make a payment to the university, taking the example of the of Sri Ghannand case Bahuguna.

Executive Council directed that five times of current market rate should be taken from Sri Ghannand Bahuguna to settle this dispute as one time and also to discourage other people from encroaching the university land.

To consider conducting of exams for session 2020-21 of Combined PG Institute of Medical Sciences and Research, Dehradun (Annexure-16)

The Combined PG Institute of Medical Sciences and Research, Dehradun, has requested for conducting the Exams for Session 2020-21 from HNB Garhwal University.

The Brief facts are that the Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun vide letter No. 1900/HNBUMU/Affiliation/18-19 dated 15<sup>th</sup> January 2018, directed the following colleges to get affiliated from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun as per provisions under Para 6 and 4 of the Act No. 72/XXXVI(3)/2014/07(1)/2014 dated 18 February 2014 of HNB Uttarakhand Medical Education University.

A copy of the letter No. 1900/HNBUMU/Affiliation/18-19 dated 15<sup>th</sup> January 2018 was also sent to Vice-Chancellor, HNB Garhwal University, Srinagar (Garhwal), requesting that the HNB Garhwal University should de-affiliate the above colleges at its own level.

Subsequently, Letter No. 1809/HNBUMU/Affiliation/18-19 dated 17<sup>th</sup> December 2018 and letter No. 1900/HNBUMU/Affiliation/19-20 dated 15<sup>th</sup> January 2019 were also received from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun.

The HNB Garhwal University, Srinagar, informed the concerned Paramedical, Nursing, and Dental Colleges individually for further necessary action as per letters received from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun.

The Petitioner institutions were also informed by the HNB Garhwal University vide letter no. Manyata/ 9277 dated 25.02.2019. Thereafter, the above paramedical, nursing, and dental Colleges were also informed through reminder letter No. Manyata/Vividh/961 dated 16.12.2020 not to give admission from Session 2020-21 in case of medical, paramedical, nursing, and dental courses.

#### Resolution:

Executive Council noted that letters have been sent to Combined PG Institute of Medical Sciences Research, Dehradun and also Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun. EC authorised Vice-Chancellor to take the further decision in this matter upon receipt of reply from both the college and university.

EC also directed that all the colleges who have already obtained NOC from the university, must be informed publicly by placing notification in university website and in one leading newspaper. Henceforth, this shall be made practice in future as well.

The College vide letter No. CIMS&R/ADD/2020-21/1210 dated 08.08.2020 requested for "NOC" for de-affiliation from Session 2019-20, and in consideration of the request, the HNBGU issued NOC for de-affiliation vide Letter No. Manyata/909 dated 18.11.2020 and the Executive Council the University also granted approval for the purpose.

Now the college has submitted its request that the Exams for Session 2020-21 for the Paramedical and Nursing Courses by the HNBGU, Srinagar (Garhwal).

The matter was earlier placed before the Academic Council meeting dated 17.02.2022 wherein the Academic Council resolved that "the university should send a letter to the Combined PG Institute of Medical Sciences & Research, Dehradun to ascertain from which date they had been affiliated with the new university. The decision for conducting the exams should be taken by the university thereafter. If they have been affiliated with the other university from Session 2021-22 onward, then exams of session 2020-21 should be conducted by the university."

The Brief facts are that the Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun vide letter No. 1900/HNBUMU/Affiliation/18-19 dated 15<sup>th</sup> January 2018, directed the following colleges to get affiliated from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun as per provisions under Para 6 and 4 of the Act No. 72/XXXVI(3)/2014/07(1)/2014 dated 18 February 2014 of HNB Uttarakhand Medical Education University.

A copy of the letter No. 1900/HNBUMU/Affiliation/18-19 dated 15<sup>th</sup> January 2018 was also sent to Vice-Chancellor, HNB Garhwal University, Srinagar (Garhwal), requesting that the HNB Garhwal University should de-affiliate the above colleges at its level.

Subsequently, Letter No. 1809/HNBUMU/Affiliation/18-19 dated 17<sup>th</sup> December 2018 and letter No. 1900/HNBUMU/Affiliation/19-20 dated 15<sup>th</sup> January 2019 were also received from Hemvati Nandan Bahuguna

#### Resolution:

Executive Council discussed this issue in detail and directed the university to conduct exam of aforesaid college for session 2020-21 only and for session 2021-22 onwards, the college should approach the **HNB** Uttarakhand Medical University, Dehradun for further affiliation and conduct of exams.

The HNB Garhwal University, Srinagar, informed the concerned Paramedical, Nursing, and Dental Colleges individually for further necessary action as per letters received from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun.

The Petitioner institutions were also informed by the HNB Garhwal University vide letter no. Manyata/ 9277 dated 25.02.2019. Thereafter, the concerned paramedical, nursing, and dental Colleges were also informed through reminder letter No. Manyata/Vividh/961 dated 16.12.2020 not to give admission from Session 2020-21 in case of medical, paramedical, nursing, and dental courses.

The Sai Institute of Paramedical & Applied Science, Dehradun, filed Writ Petition No. 429 of 2021 (M/S) before the Hon'ble High Court of Uttarakhand. The Hon'ble Court, in its Order dated 17.08.2021, directed the respondents (HNBGU) to declare the result of the students for the said academic years. A writ of mandamus was issued by the Hon'ble Court to respondent no. 2 (the HNB Garhwal University) to declare the result of the students for the academic years 2019-20 and 2020-21.

The HNBGU sought legal opinion on the matter in order to proceed further on the issue. In the legal opinion, Dr. Kartikeya Hari Gupta, Advocate (counsel for the university), opined that:

"Hon'ble Court has not provided any timeline for such declaration of result of Session 2020-21 hence; it is natural that such result may be declared after students' enrolment and other due examination procedures. However, it is humbly requested that to comply with the Hon'ble Courts' Orders in letter and spirit and looking at the interest of students, the above mentioned may be done on an expeditious basis.

Hence, there is no need to file Modification Application in the present circumstances."

The matter was earlier placed before the Academic Council meeting dated 17.02.2022 under Agenda item No. 16.17, wherein the Academic Council resolved that "the university should file review appeal in Hon'ble High Court against the above-said decision as stated in the agenda no.16.17".

The request of the college, along with the orders of Hon'ble High Court and legal opinion on the matter, is hereby submitted for kind consideration and directions of the Executive Council.

#### Agenda Item No. 17.14

To consider and decide about issuing Notification regarding Affiliation for Session 2017-18, 2018-19, and 2019-20 (Annexure-18)

#### Resolution:

Executive Council discussed in detail this matter and approved to issue



The University administration, in its endeavour to maintain an all-India character and high standards of teaching, research and to ensure transparency in the admission of students, recruitment of faculty, and also to accomplish the goals of e-governance through digitization, had vide Notification/Letter Nos. HNBGU/Manyata/2021/225 dated 17-09-2021, HNBGU/Manyata/2021/408 dated 31-12-2021, HNBGU/Mayata/2021/2021/418 dated 06-01-2022 and Office Order No. HNBGU/Affiliation /2022/424 dated 14.01.2022 issued Notifications to the colleges and directed the Management Committees of all concerned colleges/institutes to apply for an extension of affiliation through online mode by getting registered on the University affiliation Module (Link: http://ums.hnbgu.ac.in#login).

As per UGC (Affiliation of Colleges by Universities) Regulations, 2009, the continuation of temporary affiliation shall be granted by the university on a "year — to - year" basis through the inspection process prescribed in the regulations. The application for such extension of approval is to be made on the prescribed form and upon payment of requisite fees.

By the last date for submission of information for the session, 2020-21, through an on-line affiliation portal, about 50 colleges submitted the information with the requisite fee, and accordingly, they have been notified to submit their information with the requisite fee for Session 2021-22.

However, by the time of the initial Notification dated 17-09-2021, for submission of information through online affiliation module, it was not possible for the university to notify the colleges/institutes to submit information through on-line affiliation portal through on-line mode for Sessions 2017-18, 2018-19 and 2019-20.

Hence, in order to maintain the continuity of the Academic sessions, it was mentioned in the notification dated 17-09-2021 that a separate notification will be issued regarding affiliation for Session 201-18, 2018-19, and 2019-20 through Off-line mode.

A copy of NOTIFICATION for Sessions 2017-18, 2018-19, and 2019-20 is hereby placed for kind perusal and approval/ratification of the Executive Council.

## Agenda Item No. 17.16

To consider and decide about a renewal of affiliation of Indian Military Academy (IMA) (Annexure-20)

The HNB Garhwal University vide Letter No. Affil./2003/421 dated 13<sup>th</sup> June 2003 granted approval to award PG Diploma in Military Studies & Defence Management. But, after the initiation of the Online Affiliation module, several notifications were issued to the affiliated colleges/institutions regarding the submission of information through the online affiliation portal. The university notified the affiliated colleges/institutions that to get an extension/renewal of affiliation with HNBGU for Session 2020-21, they should submit all the relevant documents with a prescribed registration fee and inspection charges. The last date for submission of information through the online portal with a fee was 19.01.2022.

The Indian Military Academy (IMA) vide letter No. 4452/Shaikshnik/Acad dated 19.01.2022 requested the following exemptions:

- a. Exempt the Academy from additional charges/fees as there is no fund/grant allocation on this head at IMA.
- b. Status quo with a request to affiliation be maintained hitherto fore.

However, a processing fee of Rs. 5000/- may be charged from this institution.

The request of the IMA is hereby submitted for kind consideration and approval, please.

# Resolution:

Executive Council discussed this issue in detail and noted that IMA is a premier academy of our country. HNB Garhwal University also feels pride to have such an institute as affiliated with it. As such, considering the national importance, Executive Council authorised the Vice Chancellor to take decision in this matter in positive manner.

Shree Sanatan Dharm Prakash Chand Girls (PG) College, Roorkee, requested vide letter No. S.D./2021-22/325 dated 29.11.2021 along with Order dated 16.11.2021 of Hon'ble High Court in WP (PIL) No. 155 of 2020 dated 16.11.2021. As per the decision of Hon'ble High Court in WP (PIL) No. 155 of 2020 dated 16.11.2021, the Hon'ble High Court has set-aside the letter dated 05<sup>th</sup> June 2020 (D.O. No. 42-10/2010-Desk (U) of Joint Secretary (CU&IISER) and letter dated 24.07.2020 (Manyata/Vividh/686 dated 24.07.2020) of HNB Garhwal University. regarding the transfer of affiliation.

In its letter dated 24.07.2020, the HNB Garhwal University had directed the affiliated colleges/institutes for further necessary action regarding the transfer of affiliation from HNBGU in response to the directions of the Ministry of Education, Deptt. of Higher Education vide letter dated 05.06.2020.

Therefore, in such circumstances, when the Hon'ble High Court of Uttarakhand has set aside the letter dated 05.06.2020 of the MoE, Deptt. of Higher Education, New Delhi, and letter dated 24.07.2020 of the HNBGU issued to the affiliated colleges regarding the transfer of affiliation.

Further, the college was issued a letter of de-affiliation vide Letter No. HNBGU/ Manyata/2021/315 dated 17.11.2021 and NOC vide HNBGU/Manyata/2021/316 dated 17.11.2021.
