For admission in **B. Pharm. II year (Lateral Entry)** for the academic year 2022-23, the second merit list is being declared on the basis of marks obtained in CUET- 2022 examination.

All the applicants of this list are hereby informed to ensure their provisional admission by depositing the fees online through their user id and password from **21.10.2022 to 27.10.2022 (05.00 pm)** through online mode in the Samarth portal (<https://hnbguCUET.samarth.edu.in>).

Steps:

01: Deposit the fees online as given above.

02: Download the admission form from the university website <https://www.hnbgu.ac.in>

03: Fill the Admission form completely and attach the photocopies of the mark sheet of High school, Intermediate, Diploma in Pharmacy (D. Pharm), CEUT–2022 score card, claimed reservation category certificates (Scheduled Caste, Scheduled Tribes, Other Backward Classes in the format prescribed by the Central Government issued after 31st March 2022, and Economically Weaker Sections etc.)

04: Attach **Original Copies** of Character Certificate, Transfer Certificate, Migration Certificate along with the Admission form.

05: The admission form must be submitted in person to the Department of Pharmaceutical Sciences for verification and thereafter the form to be submitted to the Dean, School of Sciences Office by 01.11.2022.

Note:

The merit list is prepared based on the soft copy of the documents submitted by the candidates. In case of any discrepancy found later at the time of physical verification with the originals, the admission will be cancelled and no claim shall be entertained in this regard.

Candidates have to submit admission fees through online mode before the last date as notified in the website and / or in this letter, failing which the seat will be offered to the next candidate.

The candidates have to submit the following during the physical verification process-

1. Three printed copies of online form, filled by you and to be submitted - one copy each at concerned Dean's office, Central Library and Proctor Office.
2. One set of self-attested photocopies of all above documents.
3. The original Transfer Certificate (TC) or Migration Certificate, Character Certificate (CC) and Affidavit for gap year period (if applicable) and Anti Ragging Affidavit (as given in Prospectus).
