Dear Applicant

On the basis of the result of CUET entrance examination-2022 conducted by the NTA, all the candidates who have paid and registered themselves for SRT Campus, Tehri Garhwal are hereby called for counseling for admission to the program LL.M. First Semester of Four Semesters Course. Therefore, you are required to appear in person for counseling as per the schedule mentioned below:

Day & Date of Counseling : Monday, 21st November, 2022

Time of Counseling : 10.00 A.M. To 05.00 P.M.

**Place of Counseling : DEPARTMENT OF LAW, S.R.T. CAMPUS, BADSHAHI THAUL,
TEHRI GARHWAL (UTTARAKHAND)**

The candidates must bring the following documents in original with one set of photocopy of all documents along with Admit Card of CUET at the time of counseling:

1. Counseling call letter;
2. High School Certificate as a proof of date of birth;
3. Mark sheet and certificate of High School, Inter, Graduation and Law Graduation (3 or 5 Years program);
4. NCC/NSS/Sports/Extra-Curricular Activities Certificates, if claiming for weightage;
5. Category Certificate for SC/ST/OBC/Defence Personnel or dependent /PH/ FF dependent issued by the competent authority. In case of OBC (Central Govt. Certificate) category candidates they are required to produce non creamy layer certificate of their parents of preceding financial year;
6. **EWS category candidates must have recent certificate which should be of the current financial year, i.e., 2022-23;**
7. TC and CC of last institution passed necessarily be submitted **(at the time of admission);**
8. Migration certificate from the institution last attended **(at the time of admission);**
9. Police Verification **(at the time of admission for out of Uttarakhand candidates).**

IMPORTANT NOTES

:

1. The candidates coming without original documents will not be considered for counseling.

2. The call for counseling itself will not confirm the admission unless the candidate is found eligible and suitable for admission to LL.M. program and the admission will be subject to the availability of seats.

3. The absentees will not be considered for counseling later on.

4. No TA and DA will be provided to attend the counseling.

5. The candidates are advised to check their eligibility before appearing for the counseling.

6. Depending upon the number of candidates, the counseling process may continue for next day. As such, the candidates are advised to bring winter clothing with them. The candidates have to make arrangements for their own stay.

7. Reaching SRT Campus Tehri:

a) Nearest railway station Haridwar, thereafter bus or taxi via Rishikesh to Badshahi Thaul, Chamba, Tehri Garhwal (approx. 100 Km.)

b) By air, the nearest airport being Jollygrant, Dehradun, then from taxi/bus to SRT Campus, Badshahi Thaul, distance approx. 80 kms.
