

## **SPOT COUNSELING INFORMATION FOR ADMISSION TO**

### **M. PHARM FIRST YEAR, 2023-24**

The counseling based on the performance in CUET(UG)-2023 will be conducted in the Department of Pharmaceutical Sciences, H.N.B. Garhwal University Srinagar-Garhwal, Uttarakhand on 19<sup>th</sup> and 20<sup>th</sup> September 2023 for two days. The applicants who have appeared in CUET (UG)-2023 and had already registered themselves through the admission portal <https://hnbguet.samarth.edu.in>, having normalized NTA score as mentioned in the table below against various categories are allowed to appear in spot counseling.

Applicants have to ensure their presence **in person** at Department of Pharmaceutical Sciences, Chauras Campus, H.N.B. Garhwal University Srinagar-Garhwal for reporting and counseling as per the given date and time. Applicants are further required to bring all their testimonials/certificates/documents **in original, 03(Three) Passport Size Photograph** and one set of attested photocopies on the reporting date.

**Note:** 1. *Candidate whose name appeared in previous merit list may also participate in spot counseling.*  
2. *Reserved Category candidates (SC, ST and Person with Disability), who are already registered may also participate in spot counseling.*

**The following documents (Two sets photocopy) must be produced at the time of Counseling:**

1. Printed copy of online application form, filled by you generated through SAMARTH portal.
2. High School Certificate as a proof of age.
3. Mark sheet of Qualifying Examination B. Pharm.
4. Transfer Certificate/ Migration Certificate, Character Certificate and Year-Gap Certificate.
5. Category Certificate for SC/ST/OBC/EWS/PWD, if issued by competent authority.
6. OBC (Non-Creamy Layer) certificate and EWS certificate must be issued after 31/03/2023 and OBC certificate should be strictly in accordance to the Central Government format.

The counseling shall be strictly based on the **normalized score (NTA Score) of CUET (UG)-2023** merit. If offered admission, the candidate has to take admission as per the date mentioned on the admission letter by filling up a prescribed Admission Form and by depositing tuition and other fee through online mode, failing which admission offer to him/her will be treated cancelled and the seat will be offered to the next candidate in the merit list.

#### **IMPORTANT NOTE:**

- The candidate may note that this letter is only for spot counseling and it does not give any guarantee for admission.
- The admission will be subject to the availability of the seats in the respective categories and fulfillment of the eligibility criteria.
- As notified in the prospectus the university cannot guarantee to provide Hostel

Accommodation to all the students admitted to above mentioned programme. No students admitted to Department can claim the hostel seat as the matter of right. If hostel seat is allotted, the students have to pay the fee and other charges of the hostel separately in addition to the tuition fee and others as stated above.
