➤ **Instructions for the selected candidates:-**

1. The following selected candidates in the first merit list under different categories have been recommended only for their **provisional admission** to M.Sc. first semester (Botany) after first counselling which was held on 01-09-2023 and 02-09-2023 after physical verification of the documents in the office of the Botany and Microbiology Department at Chauras Campus, Srinagar (Garhwal).
2. The candidates whose **result of B.Sc. last semester is awaited** are also given provisional admission vide the University notice no. **HNBGU/DSW/2023/83 dated 28.08.2023**, if they don't have any credit arrears till UG 5<sup>th</sup> semester. Such candidates have to **submit an undertaking on affidavit** regarding production of the final semester mark-sheet/result till 25<sup>th</sup> September, 2023, failing which their admission will be considered as cancelled.
3. The candidates in the merit list can log on to their admission portal i.e., <https://hnbguuet.samarth.edu.in> by using their registered user id and password for further fee submission. The fee structure for admission is available on the portal.
4. **The selected students have to deposit their admission/course fee for admission to M.Sc. First Semester (Botany) latest by September 11<sup>th</sup>, 2023.** It is compulsory to deposit the admission/course fee on or before the due date. After that the portal will automatically be closed and admission of such candidates will be cancelled and seat will be offered to the next candidate from merit.
5. After depositing the admission/ course fee the candidates have to **send a scanned copy of their fee receipt to the email id [hodbotmicro.hnbgu@gmail.com](mailto:hodbotmicro.hnbgu@gmail.com) latest by September 11, 2023.**
6. The candidates whose any of the required documents are due at the time of counselling are hereby informed to submit them with their admission form. The admission to M.Sc. Botany course will be confirmed only after the submission of required admission fee and all other essential documents of the candidates. The candidates have to mandatorily submit their original TC, CC (not older than six months) and Migration Certificate (belonging to other Universities) along with a duly signed admission form.
7. The date for submitting the admission form will be intimated separately to those candidates only who will deposit their admission/course fee on or before the due date. Therefore, candidates are suggested to check regularly the University website and their e-mail for further updates.
8. For query related to the hostel accommodation, the admitted students can check the university website [www.hnbgu.ac.in](http://www.hnbgu.ac.in) and need to apply, separately.
