The **third merit list** for admission in M.Sc. first semester (Mathematics), session 2023-24, at **S.R.T. Campus Badshahithaul, Tehri Garhwal** is declared based on CUET score obtained by the students. All the students on the merit list are hereby informed to ensure their **provisional admission** from **14.09.2023 to 20.09.2023** through online mode in the **Samarth portal** by depositing the fee through their user ID. After fee submission, download the admission form from the **University website** (www.hnbggu.ac.in) and fill it completely and attach the photocopies of the mark sheet of High School, Intermediate, B.Sc., CUET score card, reservation (SC/ST/EWS) certificate and OBC certificate in the Central Government format.

Students are also required to attach the original copies of character certificate, transfer certificate, migration certificate and **police verification (only for other state students)** along with their admission form. The complete admission form must be submitted to the Department of Mathematics by 21.09.2023 and get all the documents physically verified.

In case of any information/document mentioned in the admission form is found incorrect, the admission of the student will be automatically cancelled.

Note: *The students whose UG last semester result is awaited will be given provisional admission, if they don't have any credit arrears in UG 5th semester. Such students will have to submit an undertaking on affidavit regarding production of the final semester mark sheet/results till 25th September 2023. Content of the undertaking (format) to be submitted on affidavit is attached herewith.*
