All the shortlisted applicants for the admission in LL.B. Ist semester, academic session 2023-24 are hereby informed that they must deposit the fee (as per prospectus) online on or before the last date for provisional confirmation of admission in the course.

The last date for online fees submission is -09/10/2023

Verification of Documents of the Candidate till 12/10/2023

Please Note: - The merit list is prepared based on documents uploaded by the applicants on the Samarth portal. In case any discrepancy is found later at the time of physical verification with **original documents**, the admission will be cancelled and **NO** claim shall be entertained in this regard and their seat will be allotted to the next candidate (in the waiting list.) The applicants may come for physical verification on any working day from 10 am to 3pm.

1. These admissions are **strictly provisional** & will confirm only after physical verification of all relevant/required documents at the time of admission. The applicants have to bring all the original documents at the time of seeking provisional admission.

2. Applicants have to provide the original documents during physical verification of documents (High School, Inter Mark Sheets & Graduation Mark Sheets, Date of Birth Certificate, SC, ST, OBC (on Government of India Format of the preceding Financial Year), EWS (if applicable of the Financial Year 2022-23) certificate, NCC/NSS/Sports Weightage Certificate (if applicable) and CUET Admit card and Score Card .

3. The applicants have to submit one set of self-attested photocopy of all above documents and Original of Transfer Certificate (TC), Character Certificate (CC), Migration Certificate & original Police Verification (for outside Uttarakhand state applicants) and Affidavit for gap year period (if applicable) and Anti-Ragging Affidavit by the Candidate and Parent and other required documents during the physical verification process.

4. Duly filled admission form of the university (which is available online) and receipt of the admission fee deposited online as admissible in the PROSPECTUS 2023-24 of the University.

5. The applicants against whose names remarks have been given need to produce the required document (as stated in the remarks) at the time of admission, otherwise they would not be considered for provisional admission.

6. The applicants who do not deposit their fee online till the last date of submission of fee will lose their right of provisional admission and the seat will be allocated to the next candidate in the waiting list.
