On the basis of the result of CUET entrance examination-2023 conducted by the NTA all the candidates **who have registered themselves for BGR Campus Pauri Garhwal and subsequently failed to attend the previous counseling or failed to deposit the admission fee, by any reason, are hereby called for counseling** for admission to the LL.B. programme against vacant seats (till date) in different categories. Details of vacant seats are given below. All are required to appear in person for last chance counseling as per the schedule mentioned below:

**Time of Counseling: 10.00 A.M. To 03.00 PM.**

**Place of Counseling: DEPARTMENT OF LAW, BGR CAMPUS, PAURI GARHWAL**

The candidates must bring the following documents in original with one set of self-attested photo copies at the time of counseling:

1. Counseling call letter;
2. CUET Score Card;
3. High School Certificate as a proof of date of birth;
4. Mark sheet and certificate of High School. Inter & Graduation.
5. NCC/NSS/Sports/Extra-Curricular Activities Certificates, if claiming for weightage
6. Category Certificate for SC/ST/OBC/Defense Personnel or dependent /PH/ FF dependent issued by the competent authority. In case of OBC (Central Govt. Certificate) category candidates they are required to produce non creamy layer certificate of their parents of 2022-23 financial year.
7. EWS category candidates must have recent certificate which should be not before 2022-23 financial year.
8. TC and CC of last institution.
9. Gap Year Affidavit, if any.
10. Migration certificate from the institution last attended.
11. Police Verification.
12. 4 Passport size photo.

**IMPORTANT NOTES:**

1. The candidates coming without original documents will not be considered for counseling.
2. The call of counseling itself will not confirm the admission unless the candidate is found eligible and suitable for admission to LL.B. program and the admission will be subject to the availability of seats.
3. The absentees will not be considered for counseling later on in any conditions.
4. No TA and DA will be provided to attend the counseling.
5. The candidates are advised to check their eligibility & availability of seats before appearing for the counseling.
6. After counseling Merit List for Admission will be uploaded on the University website on 11.10.2023 & deposition of fees on 11.10.2023 to 12.10.2023 only.
