Dear Sir / Madam,

Please refer to my D.O. letter No. 2-18 / 2023 -P.N.II dated 30<sup>th</sup> April, 2024 in connection to capturing details from the Centrally Funded Higher Education Institutions about the status of implementation of the provisions of National Education Policy, 2020 in their Institutions on some of the key themes of NEP, 2020 (enclosed).

2. Ministry has established a central monitoring cell named National Insight Centre for Education (NICE) to centrally monitor the progress of NEP and other interventions. To capture the data on near real time basis, NICE team has developed "Centrally Funded Higher Education Institutions: NEP Progress Monitoring Webform" for better data integration and analytics. This Web Form is accessible via link <https://nice.education.gov.in/CFI-web-forms/>. A user manual for "Centrally Funded Higher Education Institutions: NEP Progress Monitoring Webform" and Data Entry process has been enclosed herewith. The data is to be filled bi-annually by all CFIs under this webform (in month of February and August in every year). At initial stage, since institutions will be participating in this activity for the first time, they will have to provide data for last 3 academic years (2021-22, 2022-23, 2023-24).

3. For this activity, this ministry has received detail of 40 Nodal Officers from various CFIs (list attached at Annexure A). The HEIs who have not appointed nodal officer/ Faculty for the said activity should furnish the details via link: <https://forms.gle/rbSxC7DxXgzLtwLj6> by 14<sup>th</sup> August, 2024. Nodal officer will get credential on his email given on link.

4. Further, an "Online Orientation cum Training Session to Demonstrate the CFI Web Form" for the nodal officer/ faculty will be conducted on 20<sup>th</sup> August. Details will be shared separately. All the Centrally Funded Higher Education Institutions to make it convenient to participate the above-mentioned training session.

5. Therefore, all the Centrally Funded Higher Education Institutions are requested to appoint nodal officers for the above said activity (if not appointed so far) and submit detail online in the CFI Web Form by 15<sup>th</sup> September, 2024.
