## After fee deposition on the Samarth portal using their ID, download the application form from the University website (www.hnbgu.ac.in) and fill it out completely. And attach the following documents:

- (i) Fee Receipt of admission
- (ii) Registration Form along with UET Scorecard
- (iii) Self-attested photocopy of marks sheets and certificates of high school, higher secondary, and UG (all semesters/years).
- (iv) Caste certificates (SC, ST, OBC-NCL, EWS, etc for weightage). Make sure that the certificates are in the prescribed format of the Central Government. OBC-NCL and EWS certificates must be issued in the current session.
- (v) Original Transfer and Character certificates and Migration certificate if, Graduation is from another university.
- (vi) Anti-ragging certificate, duly signed by the applicant and his parents.
- (vii) Police verification certificate (Only for students residing outside Uttarakhand)
- (viii) Character certificate of last six months from Gazetted Officer if, there is a gap period.

Admission will be provisional. If any information is found false at any stage, the admission will be automatically cancelled. If the candidate fails to submit any required document with the admission form, he/she will have to submit an affidavit on Ten rupees Stamp paper to submit the same within twenty days, otherwise, the admission will be cancelled. All the students of B.Ed. last semester whose result is still awaited and who have registered themselves on SAMARTH portal in PG programmes may be given one month's time period for submitting their final year mark sheet and transfer certificate.
