Notice for Offline/ Physical Reporting/ Counseling (against vacant seats) on 18th September, 2024 B. Tech. First Semester Admission (2024-25)

(Based on CUET (UG)-2024 merit, and only for the candidates who had already registered by the due date)

It is informed that Offline/ Physical Reporting/ Counseling, based on CUET (UG) score - 2024, for admissions in the 1st semester of B. Tech. (Instrumentation Engineering (IE), Information Technology (IT), Mechanical Engineering (ME), Computer Science and Engineering (CSE), and Electronics and Communication Engineering (ECE)) programmes in this university, for the session 2024-25, is scheduled to be held **on 18th September, 2024**, to fill up the vacant seats.

The Offline/ Physical Reporting/ Counseling will be held as per the following schedule (Table-1):-

Candidates for reporting must observe the following things:

- 1. Candidates should have registered for admission in 1st Semester B.Tech in H N B Garhwal University *through SAMARTH Portal*.
- 2. Candidate who have already admitted in any branch of B.Tech programmes, are not required to report for offline reporting. Their branch upgradation will be taken care of automatically as per their preferences.
- 3. Vacant seats matrix will be displayed at university website on 14th September, 2024.
- 4. Candidates are advised to see the third merit list published at university website for category-wise cut-off score for different B.Tech programs.
- 5. Candidates who will report after 01:00 p.m. will be not considered for offline counseling.
- 6. Eligibility criteria, admission fees details etc., are available in the prospectus 2024 available at university website.

The following documents must be produced at the time of Reporting/ Counseling:

- Printed application form, filled by candidate through the SAMARTH portal.
- One set of self-attested photocopies of Aadhaar ID, Class 10th Certificate/ Mark sheet, Class 12th mark sheet, CUET (UG) 2024 Score Card, Certificate (if applicable) of OBC-NCL/ SC/ ST/ EWS/ Ex-Service Man/ PwD category/ sub-category, NCC/ NSS certificate, etc., and all other relevant documents. OBC-NCL (in the format of Central Government) and EWS Certificates must be issued on or after 1st April, 2024.
- Original Transfer Certificate (TC) or Migration Certificate, Character Certificate (CC), Affidavit for the gap year period (if applicable), and Anti-Ragging Affidavit (as given in the University Prospectus 2024–25).
- Five (05) passport size photographs.

If admission is offered, the candidate has to take admission by 5:00 p.m. on 18th September, 2024, by filling up a prescribed Admission Form and by depositing tuition and other fees, failing which the allotted seat to him/her will be treated as cancelled. The admission will be subjected to the availability of the seats in the respective categories and fulfilment of the eligibility criteria.

Note that the university has a limited hostel facility, and the university does not provide Hostel Accommodation to all the admitted students to above mentioned programs. To avail the hostel facility, the admitted students will have to apply separately. If hostel seat is allotted, the students have to pay the fee and other charges of the hostel separately in addition to the admission fee.

In view of the present weather/ road conditions of the region, the candidates are advised to arrive one day before the reporting date.
