After scrutiny, successful candidates can submit the admission fee through online mode in the Samarth portal (<https://hnbguCUET.samarth.edu.in>). After submitting the fees, download the admission form from <https://www.hnbgu.ac.in> and fill it completely.

Bring all the original documents along with one set of photocopies of **certificate and mark sheet of High school and Intermediate; registration form, admit card, score card of CUET-2024 and fee payment receipt**. Also bring the **reservation certificates (Scheduled Caste, Scheduled Tribes, OBC, EWS and PW), 03 certificate in original (Character Certificate, Transfer Certificate and Migration Certificate) and weightage certificate (Sports/NCC/NSS/Defense, if any)**. The latest OBC and EWS certificate should be in the format prescribed by the Central Government and issued within one year of the date of admission. The admission will be confirmed only after verification/confirmation of the original documents.

If any discrepancy found after physical verification, the admission will be automatically treated as cancelled and no claim shall be entertained in this regard.
