Applicants have to come with the original documents during physical verification of documents (High School, Inter Mark Sheets & Graduation Mark Sheets (Final Semester/Year Marksheet with result), SC, ST, OBC (on Government of India Format of the preceding Financial Year), EWS (if applicable of the Financial Year 2023-24) certificate, NCC/NSS/Sports Weightage Certificate (if applicable) and University Entrance Test Admit card and Score card.
- 4. Applicants also have to get **a photocopied set** of all the documents as stated in point no. 2 and 3.
- 5. If selected (if name comes in merit list) then the selected candidate also must bring TC and CC in original (not more than six months old) of the last institution attended, Gap year Affidavit (if applicable) and police verification (for out of Uttarakhand candidates) at the time of physical verification of documents in the department.
- 6. Merely appearing in counselling will not ensure admission of the Applicant.
- 7. Merit list will be declared on the University website after the counseling.
