7. Anti Ragging Form (*Students have to visit the website www.antiragging.in to fill the Anti-Ragging Undertaking Form online using email id. Applicant will receive the attachments, then download the Undertakings, take the Printout, Sign it (Self attested), and Submit to the Admission Committee.*)
8. Police Verification (Only for Applicants out of Uttarakhand State).
9. Category Certificate (SC/ST/EWS) & OBC Certificate (latest by Six Months).
10. Affidavit & Character Certificate (CC) issued by any Gazetted Officer (for Gap Year Applicants).

***Applicants must be present physically with all the original documents on the date of counseling/document verification. In case of any information/document mentioned in the admission form is found incorrect, the admission of the applicant will be automatically cancelled.**
