## Information Regarding Admission in LL.B. 1st Semester

## Instructions for the re-open fee applicants

All the shortlisted applicants for admission in LL.B. 1st semester (Three-year course), academic session 2025-26, are hereby informed that they must deposit the fee (as per prospectus) online on or before the last date for provisional admission in the course which is from 10/10/2025 to 12/10/2025. Verification of Documents of the applicants will take place in offline mode in the Department of Law, BGR Campus, Pauri, Pauri Garhwal from 13/10/2025 to 14/10/2025. The applicants may come for physical verification between 10 am to 3 pm. In case any discrepancy is found later at the time of physical verification with original documents, the admission will be cancelled, and NO claim shall be entertained in this regard.

- 1. These admissions are strictly provisional & will confirm only after physical verification of all relevant/required documents at the time of admission. The applicants have to bring all the original documents at the time of seeking provisional admission.
- 2. Applicants have to provide the original documents during physical verification of documents namely, High School Marksheet, Inter Mark Sheet & Graduation Mark Sheets of all semesters, Category Certificate-SC, ST, OBC (on Government of India Format of the preceding Financial Year), EWS Certificate (if applicable of the Financial Year 2024-25) NCC/NSS/Sports Weightage Certificate (if applicable),or any other category in which the candidate is claiming admission. UET Admit card, UET Score card, Registration form along with duly filled admission form of HNBGU (which can be downloaded from the University website), Aadhaar card and fee receipt (2 copies) and Six (6) passport size photographs.
- 3. The applicants have to submit one set of self-attested photocopy of all the above documents and Original of Transfer Certificate (TC), Character Certificate (CC), Migration Certificate & original Police Verification (for outside Uttarakhand state applicants) and Affidavit for gap year period (if applicable) and Anti-Ragging Affidavit by the Candidate and Parent and other required documents during the physical verification process.
- 4. The applicants who do not deposit their fee online till the last date of submission of fee will lose their right of provisional admission. For any clarification, you may contact:
