The 33rd Meeting of the Executive Council of Hemvati Nandan Bahuguna Garhwal University, Srinagar Garhwal, is convened in Hybrid mode on Friday, April 17, 2026 from 11:00 AM onwards to deliberate on the agenda circulated earlier and to take decisions on the agenda items.

At the outset, the Chairperson welcomed all the distinguished members of the Executive Council and expressed gratitude to the Hon'ble members of the EC for sparing their valuable time for participation in the meeting. The Vice Chancellor appraise the Council with the major events taken place in the University after previous meeting of the EC. The Council expressed its appreciation for successful organization of the 12th Convocation of the University on 24th March, 2026. The Council was also apprised with the disposal of WP PIL No 209 of 2025 by the Hon'ble High Court of Uttarakhand vide order dated 15-04-2026 whereby appointment of the Vice Chancellor of the HNBSGU pronounced to be in conformity with the Central Universities Act, 2009, Statutes framed thereunder and the UGC Regulations, 2018.

The Council meeting was attended by Sh. Praveer Saxena, Under Secretary MoE, a member nominated by the Secretary MoE under clause 12(3) (1) (x) of the Statutes contained with the Central Universities Act, 2009 with Sh. Partha Kansabanik, Dy. Secretary MoE. Before formal proceedings of the Council meeting, the representative member of the MoE apprised the council with an issue regarding a complaint letter dated 11-04-2026 received by the Ministry through the


Office of the Hon'ble Minister of Education, GoI, whereby, a group of three Non-Teaching staff of HNBGU under the banner of 'Shikshenettar Karmchari Parishad' jointly made allegations against Sh. Praveer Saxena, Under Secretary, MoE, and threatened to organise an intense agitation if Shri Saxena attends this Meeting of the Executive Council as representative of the Ministry. The Council expressed deep concern over such unwarranted communication made by the Non-Teaching staff of the University against member of the Executive Council, and unanimously condemned such an act of forwarding baseless allegations/threats to the higher authorities. After deliberation on the issue, the Council advised the Registrar of the University/ Secretary, Executive Council HNBGU to issue a notice to all the employees to refrain from communications to the higher authorities without proper channel, failing which appropriate disciplinary action as per rules shall be initiated.

The Council acknowledges the constructive inputs provided by Sh. Praveer Saxena as a nominated member of the Ministry in the Executive Council, for facilitating informed decision-making and strengthening institutional governance. The Council places on record its appreciation for the contributions and timely intervention of the nominated member representing the Ministry of Education.


