OFFICE ORDER

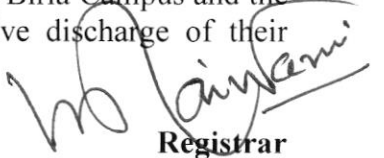
In exercise of the powers conferred under the provisions of the **University Act and Statutes**, read with **Ordinance No. 04 relating to the terms, conditions and appointment of Directors of Campuses**, and with a view to ensuring effective, efficient and coordinated administration of the **Birla Campus, situated at the University Headquarters**, the Vice-Chancellor is pleased to appoint **Prof. H. B. S. Chauhan, Department of Anthropology**, as **Director, Birla Campus of the University**, in addition to his existing duties and responsibilities.

The appointment shall be for a period of **two (02) years or until the date of superannuation, whichever is earlier**, with effect from the date on which Prof. H. B. S. Chauhan assumes charge of the said assignment, or until further orders, whichever is earlier.

Further, **the Director of the Extension Campus–Chauras Campus is hereby redesignated as the Associate Director, Extension Campus–Chauras Campus**, with effect from the date of issuance of this Office Order. The Associate Director shall discharge such duties and responsibilities as may be assigned from time to time by the competent authority.

It is further ordered that **two (02) Joint Directors shall be appointed in due course to assist the Director, Birla Campus**, comprising **one (01) male faculty member and one (01) female faculty member**, as may be decided by the competent authority. The Joint Directors shall perform such functions and responsibilities as may be assigned by the Director, Birla Campus and/or the Vice-Chancellor from time to time.

All concerned are directed to extend necessary cooperation to the Director, Birla Campus and the Associate Director, Extension Campus–Chauras Campus for the effective discharge of their respective responsibilities.
