REVISED OFFICE ORDER

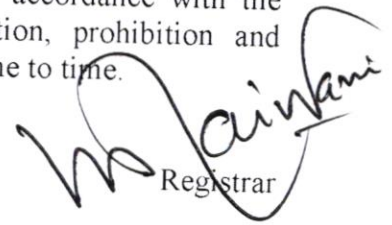

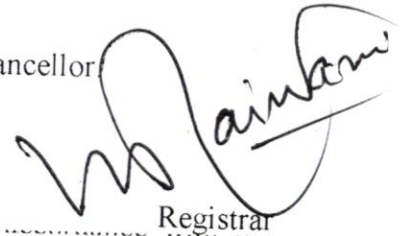
